Important events to be reported: Issuance of CIIF by the FSA

The management of ROCA INDUSTRY HOLDINGROCK1 S.A. (hereinafter referred to as the "**Company**"), informs the market that on 20 February 2024, the Financial Supervisory Authority issued the Certificate of Registration of Financial Instruments no. AC-5459-2/20.02.2024 (the "**CIIF**").

The CIIF certifies the registration of the share capital increase operation with a number of 7,172,649 new shares, which were issued on the basis of the resolution of the extraordinary general meeting of shareholders of the Company dated 22.06.2023.

As a result of the share capital increase, the new share capital of the Company amounts to RON 248,672,220, divided into 24,867,222 registered shares in dematerialised form, with a nominal value of RON 10 each.

The Company is in the process of finalizing the registration of the share capital increase, and the new shares are currently to be registered with the Central Depository, in accordance with the applicable legal provisions.
