Important events to be reported: Granting of the application for the provisional suspension of enforcement proceedings

Further to the previously published current reports no. 29/2026 and 30/2026, regarding the legal proceedings initiated in connection with the transaction for the acquisition of a 30% equity interest in Workshop Doors S.R.L. and the enforcement measures subsequently ordered against ROCA Industry Holdingrock1 S.A. (“**ROCA Industry**” or the “**Company**”), we hereby inform you that the competent court has granted the application for the provisional suspension of the enforcement proceedings.

In order to protect the rights and interests of the Company and its shareholders, ROCA Industry challenged the enforcement proceedings and the measures ordered in connection therewith and filed applications for the suspension of the enforcement proceedings.

By the Order issued on 21 August 2026 in case file no. 30681/300/2026, the Bucharest District 2 Court granted the application filed by ROCA Industry and ordered the provisional suspension of the enforcement proceedings. The court’s ruling, in summary, reads as follows: “*Grants the application for the provisional suspension of the enforcement proceedings filed by the applicant, ROCA Industry Holdingrock1 S.A., against the respondent, Dudea Adina-Loredana. Orders the*

provisional suspension of the enforcement proceedings that are the subject matter of enforcement file no. 4617/2026 of SCPEJ Coșoreanu & Asociații until the application for suspension of the enforcement proceedings that is the subject matter of case file no. 30680/300/2026 pending before the Bucharest District 2 Court is determined. No appeal is available.”

The application for the suspension of the enforcement proceedings, as well as the challenge to the enforcement proceedings, are to be determined by the competent court in accordance with the applicable legal procedures.

The Company will keep the market informed of any relevant developments in these proceedings, in accordance with the applicable ongoing disclosure obligations.
